Delegates should arrive on the first day at 07.45hrs for registration.

Delegates must be 18 years or over. Previous experience in Rigging, Lifting, Slinging and/or Crane Work is an advantage but not a requirement. Delegates must be in good health and physically capable of operating manual lifting equipment. Delegates will be expected to complete a medical screening questionnaire and sign a trainee waiver of liability and hold-harmless agreement. Delegates will also require photographic identification.

A full compliment of Personal Protective Equipment (i.e. coveralls, hard hat, safety boots and gloves) is required to participate in the practical exercises for the majority of our courses including industrial manual handling.

Delegates must be appropriately dressed for all weather conditions. Rigging & Slinging and Banksman / Flagman courses involve hands-on training in a workshop and outside in the practical training area. Warm clothing and waterproofs should be taken as a precautionary measure.

Firearms. Firearms are not allowed anywhere in, or around the training facility.

Delegates will be examined / tested on their knowledge of lifting equipment and operations. Questions will be asked on the safe use of various types of equipment, the SWL of rigging in accordance with its physical size and safe lifting practices, etc.

Due to the hazardous nature of lifting operations, NSL have a Zero Tolerance policy with regards to the abuse of drugs and alcohol.

Lunch and refreshments shall be provided each day and the cost is included in the course fee.

These charges are based on how many days before your course begins that we receive your cancellation. These charges are a percentage of the total cost of your course.
